This being the first meeting after the election of City Officials., the main order of business was to install the newly elected Officers. Mayor Bennett was re-elected as Mayor, his opponent being John Bible, who recieved twenty-three (23) votes, and Mayor Bennett recieved one hundred-forty (140). Leonard Peoples, who was un-opposed recieved a very good complimentary vote of one hundred-thirty nine. Much interest was shown in the election.

Justice of the Peace, Sam Neal , was asked by Mayor Bennett to install the newly elected officers, which was done at this meeting.

Alderman Peoples said that he had been approached about two or three of the lights which had been installed as street lights by private individuals, and was asked if the City could and would take these lights over. Alderman Peoples was asked by Mayor Bennett to look into this matter and see if it would be to the City's advantage to do this. It was thought at this time that it would be proper to do this.

The proposed Sanitary Land Fill, backed by TVA, is still in the process of being brought to a reality and some definite information should be recieved in the near future.

Mayor Bennett reported that Kimball's share in the Civil Defense Program through June 30, 1971, was one hundred-sixty- six (\$166.00) dollars.

There being no further business, the meeting was adjourned.



The Board of Mayor and Aldermen of the Town of Kimball met at the Town Office for its regular meeting on May 27, 1971 at 7:00 P. M. The following business was transacted:

Mayor Bennett was authorized to contract with the county road commissioner and arrange for paving the area in front of the fire hall, and patching and repairing the town streets. The Mayor was unanimously authorized to enter into contracts on behalf of the Town for participating in the co-operative landfill agreement with Marion County and other municipalities of the county. Alderman Shook advised the board that he had moved out of the corporate limits of Kimball and was therefore tendering his resignation as Alderman. His resignation was accepted by Mayor Bennett and Alderman Peoples. Thereafter, pursuant to the authorization contained in TCA 6-131 Mayor Bennett nominated Mr. Charles C. Atnip as Alderman to fill the vacancy created by the resignation of Alderman Shook. No other nominations were made and upon rollcall vote Mayor Bennett and Alderman Peoples voted for the election of Mr. Charles C. Atnip to fill the unexpired term of Alderman Shook. Paul A. Swafford advised the board that he could no longer act as the attorney for the Town to the fact that he was acting Circuit Judge. Whereupon on nomination of Mayor Bennett and the unanimous approval of the entire board of Mayor and Aldermen, Paul D. Kelly, Jr. was appointed to act as attorney for the Town. The term commencing June 1, 1971. There being no further business the meeting adjourned.




Alderman Atnip stated that a minor drainage problem existed on Highway 41 and that this matter was being looked into.

The Board of Mayor and Aldermen of the Town of Kimball, Tennessee, held its regular meeting August 26, 1971. All members were present.

The meeting was called to order and minutes were read.

A discussion concerning the new Business Tax Act was held by the Board and it was the opinion of all that the Town of Kimball should adopt this Business Tax Act as it effected only the businesses. This would provide additional revenue for the Town of Kimball.

Mayor Bennett read a letter from the Tennessee Planning Commission concerning the signs in the State of Tennessee. They stated that Tennessee would , in all probability, be a Hold out. They suggested that we adopt an Ordinance regulating the type and sizes of signs within the City Limits, and that this is what other towns are doing. It was agreed by all members that we do this and when we saw the necessity to enforce this Ordinance we would do so. Mayor Bennett stated that he continues to receive complaints about this situation.

The possibility of fixing the Kimball Lane Road is not very good. This has been one of the improvements that the commission had hoped to make, but the cooperation of all the property owners is needed. Some are willing to give right-of-way while others are not. Alderman Peoples reported that he had been approached on this just recently and he assured them that we were more than willing to re-build the road when all the people were willing to give necessary right-of-way.

Alderman Peoples reported that all vapor lights were in good order and no recent complaints had been received.

Mayor Bennett had consulted Attorney Kelly about annexing a portion of land to the Town of Kimball. This land would include the Tennessee Metallurgical Plant. The procedure was presented to the Commission. It was decided to go ahead with the annexation plans which would be by ordinance. This plan would consist of four phases and the commission understood the possibilities of completing or not completing the annexation.

Mayor Bennett agreed to get a copy of the Town Charter, and Alderman Peoples was to get a map showing the Town Territory involved.


