Jack Keef called the meeting to order at 5:00 pm and roll was called. Terry Case made the motion to approve the minutes from the previous meeting, seconded by Chester Blevins. All were in favor.

#### Under new business:

Josh Dobson came to the monthly meeting January 8, 2009 with a proposal to sell the 20.21 acres left to the town for \$175,000.00. Mayor Jackson and the board of aldermen refused this offer because of an earlier agreement 1 1/2 years ago of \$150,000.00 for the complete 23 acres. The town has decided to fix the railroad entrance and forget buying the property at this time.

The town received the Grant application. Mayor Jackson has signed it and it has been returned.

We will be advertising soccer thru the local papers, radio, flyers to the elementary and middle schools in Jasper and local cable stations.

Anyone interested being a coach will fill out a form and a background check will be done by the Kimball Police Department.


The membership application in the amount of \$300.00 will be sent in with the association officer paper with the names of those who have volunteered at this time. There will be four Saturday's in February to sign up. The dates will be February 7<sup>th</sup>, 14<sup>th</sup>, 21<sup>st</sup> and the 28<sup>th</sup> from 9am till 12 noon. The fee to play soccer will be first child \$45.00, second child \$35.00, third child \$20.00, and if there are four or more children per family the fee will be \$100.00. If a child can't afford to pay he or she will not be turned away.

The soccer fields will be fertilized and Mr. Vinson will keep them mowed.

Mark O'Leary made the motion to adjourn seconded by Chester Blevins.
